At a regular meeting of the Township Board (the "Board") of the Chassell Township, Houghton County, Michigan (the "Township), held on the 9th day of January, 2019.

The following preamble and resolution were, upon motion, submitted by Dave Ma Hson

WHEREAS, pursuant to Act 188, Public Acts of Michigan, 1954 as amended, ("Act") a public hearing was held on the 9th day of January, 2019, to hear and consider objections to the special assessment roll made to assess all of the costs of the Chassell Township Eurasian Milfoil Program (the "Program") to properties in the Chassell Township Eurasian Milfoil Special Assessment District (the "District"); and

WHEREAS, the special assessment roll has been presented to the Board and the Board has determined that the special assessment roll should be confirmed.

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The total estimated cost of the Program to be assessed against the 103 parcels of land in the District over a five (5) year period (2019 through 2023) is \$94100. The total annual assessments of the said Program are estimated to be as follows:

The total assessment against each parcel in the district is \$1.50 per front foot on Pike Bay per year. (See attached Exhibit 1.) Under the Program, assessments would be made in 2019 through 2023 for treatment to occur in 2019 through 2023.

2. The Chassell Township Eurasian Milfoil Special Assessment District Roll (the "Roll") assessing the aforesaid total to cover expenditures for the program against the District is ratified, confirmed and adopted.

3. Each special assessment will be payable in five (5) annual installments, with each annual installment due and payable without interest or penalty on or before the Summer Property Tax Bill due date of each year beginning in 2019. Any unpaid annual assessment will be included on the December 1st Winter Tax Bill for that year.

4. The portion of any installment which is not paid by when it is due, shall bear interest from the first day after it is due and until paid, at the rate equal to 5% percent (5%) per year. If any installment is not paid when due, then such installment shall be deemed to be delinquent and there shall be collected thereon a penalty at the rate of 1% for each month or fraction thereof that such assessment remains unpaid before being reported to the Board for reassessment upon the Township tax roll.

The Clerk is hereby directed to endorse on the assessment roll the date of this confirmation and to attach her warrant as required by law to the Roll and to direct the Roll, with her warrant attached, to the Treasurer. The Treasurer shall thereupon collect the special assessments in accordance with the terms of this resolution, the warrant and the statutes of the State of Michigan, and as of the 1st day of September following the date when installments become due under this resolution, shall submit to the Township Board a delinquent special assessment roll for reassessment on the annual Township tax roll for all delinquent installments, interest and penalties as of that date.

6. All resolutions and parts of resolutions insofar as they conflict with the provisions of the within Resolution be and the same are hereby rescinded.
