It is recommended to apply for a State Waterways grant in April 2021, because there are not as many funds available for 2020. The estimated cost of the full project is \$589,000. Traverse Engineering will send us an invoice for \$10,000. The township will pay for the study out of the Recreation Millage and will get reimbursed 50% by the DNR. Keith Meyers commented that a Portage Health Foundation (PHF) grant for \$20,000 for the kayak portion of this project (12'x18' ADA accessible floating kayak launch). If the PHF grant is obtained it can be used towards match money for the above project.

FIRE DEPARTMENT: Fire Chief Judson reported 0 calls and 10 calls to date. First Responders reported 10 calls and 26 to date. Fire Chief Judson reported that last week, the electrical meeting on the building was dislodged from away from the building by falling ice. It was repaired and power restored. He also reported that the department was able to locate a 2003 Sterling 1500 gal tank truck, 29,000 miles and 320 pump hours. This will improve the townships ISO rating and improve safety for the community. Last year a similar vehicle was ~\$600,000. Motion by Dave Mattson to approve financing the truck with a down payment of \$9,900 and a loan of \$80,000 for 3-4 years, supported by Dan Palosaari. M/C.
