**OPERATIONAL MILLAGE**

Shall the previous voted increase in the tax limitations imposed under the Article IX, Sec. 6 of the Michigan constitution in Stanton Township, of 2 mills (\$2.00 per \$1,000 of taxable value), reduced to 1.9172 mills (\$1.92 per \$1,000 of taxable value) by the required millage rollbacks, be renewed, and increased up to the original voted 2 mills (\$2.00 per \$1,000 of taxable value) and levied for 4 years, 2025 through 2028 inclusive, for the fire departments' general operating purposes, raising an estimated \$140,811 the first year the millage is levied?

The estimated amount of revenue that would be collected for the year is \$28,875.
